### **Grangeville at a glance:**

In the 1860's and early seventies, prospectors and gold seekers crossed a large meadow on the Camas Prairie on their way to the Gold Fields near Florence and Elk City. That meadow later became the incorporated City of Grangeville in 1889, and in a few short years gained the designation of the County Seat of Idaho County in the election of 1902.

Today Grangeville is home to approximately 3,400 residents. Major businesses in and surrounding the city include retail stores, banks, a lumber mill, aviation repair facilities and a car dealership. The county airport is located just outside the city limits and serves private and government aviation. Grangeville is home to K-12 schools that serve the city and surrounding area. Emergency medical services in the area are provided by Syringa Hospital.

### **Job Summary:**

This position performs general and investigative police work involving the protection of life and property, apprehension of criminal offenders, enforcement of laws and ordinances, and the preservation of peace. Work normally involves patrol, investigation, and traffic enforcement duties, which may be performed in police vehicles or on foot. Grangeville Police Officers are strongly oriented toward community services and support community based law enforcement practices. Initial assignment will be to the Patrol Section. Patrol officers work seven 12 hour shifts during an 84 hour (2 week) pay period.

## **Testing:**

Testing will consist of the Idaho POST Physical Standards test for entry level applicants and out of state lateral applicants (add website info for qualification test). Lateral applicants with a valid Idaho POST Patrol certificate will not be required to complete the Physical Standards Test. Further testing of suitable candidates will consist of a written exercise and an oral interview. Scores from the written exercise and oral interview will be used to determine ranking. Top ranked candidates will be offered a Chief's Interview. Applicants will be notified of the testing date by mail. Interview times will be given out after the physical portion of the testing process. The P.O.S.T. ## **APPLICANTS MUST MEET THE FOLLOWING REQUIREMENTS**

Be 21 years of age, a US citizen, be able to read and speak fluent English, be in excellent physical condition, and possess, or be able to obtain and retain, a valid Idaho State driver's license.

Applicants must possess a High School Diploma or GED.

## **Disqualifying factors:**

No felony convictions.

No illegal use or possession of any drug within five years of the last date to file application.

No illegal sale of any drug.

No crimes of Moral Turpitude

No crimes of Domestic Violence including misdemeanor convictions.

Discharge from military service under dishonorable conditions.

Other misdemeanor convictions, including traffic violations, will be reviewed on a case-by-case basis.

Suspension or revocation of driving privileges in Idaho, or any other state, is reviewed on a case-by-case basis.
