PURPOSE AND DEFINITION

An alcohol beverage license is required by the Grangeville Municipal Code for protection of the citizens and businesses operating in the City.

WHEN REQUIRED

An alcohol beverage license is required when any person is:

- · Selling or dispensing liquor;
- Selling or dispensing beer or wine by the drink;
- Selling or dispensing beer or wine by retail.

Each business location is considered to be a separate business and requires a separate alcohol beverage license. If your business changes ownership or if you move your business to a new location, the alcohol license is automatically void. A new alcohol license is required if either event takes place.

HOW TO APPLY

You may obtain an alcohol license application from City Hall or www.grangeville.us.

TIME FRAME

A license review takes approximately fifteen (15) working days from the time we receive the license applications to the time you receive your license. In some instances, the time frame may be longer due to the State and County licenses, and Council meeting dates. Annual renewal applications should be submitted prior to January 1st each year.

REVIEW PROCESS

When the completed alcohol beverage application has been received, with copies of your state license and county license number attached (unless they are pending issuance), the applications are sent to the Police and City Hall Departments for review. After review, the applications are added to a City Council agenda for approval. After approval by the City Council, licenses will be issued to the applicant. Please note: No City license will be issued unless the City has a copy of the state license and the county license number.

STATE AND COUNTY ALCOHOL LICENSES REQUIRED

You will also need a State alcohol license and a County alcohol license. You may apply for your City alcohol license during the interim of receiving your state and county licenses, but you will need to provide a copy of your state license and county license number prior to the issuance of your City license. For transfer of ownership or new applications, a copy of the state application must be attached.
