

***SUMMARY OF GRANGEVILLE CITY ORDINANCE NO. 946***

COMES NOW, THE CITY OF GRANGEVILLE, IDAHO, pursuant to the provisions of Idaho Code Section 50-901(A) and hereby provides a summary of City of Grangeville Ordinance No. 946 relating to the City Water and Sewer System.

Pursuant to said section the City provides information as follows:

- a) This ordinance relates to the City of Grangeville, Idaho County, State of Idaho.
- b) The identification of the ordinance is Ordinance No. 946 of the City of Grangeville, passed on the 2<sup>th</sup> day of November, 2020.
- c) A descriptive title of the ordinance shall be “An Ordinance Amending Title 8, Chapter 5 of the Municipal Code of the City of Grangeville Relating to the City Water and Sewer System.”
- d) A summary of the principal provisions of this ordinance, which is to be effective upon its publication in the Idaho County Free Press, is as follows:
  - 1) The ordinance establishes that the Water System is the property of the City.
  - 2) The ordinance establishes a Water Superintendent to act under the direction of the Mayor and City Council.
  - 3) The ordinance defines terms used throughout the ordinance, and establishes a method for calculation of charges for water and sewer services.
  - 4) The ordinance establishes sewage rates and collection procedures.

- 5) The ordinance establishes wastewater treatment plant fees and collection procedures.
- 6) The ordinance establishes water connection charges and collection procedures.
- 7) The ordinance establishes water meter rates.
- 8) The ordinance establishes collection procedures for charges for use of municipal water, sewer, solid waste collection and street light billing.
- 9) The ordinance establishes charges for delinquencies in payment and shutoff procedures for non-payment.
- 10) The ordinance provides that sums received shall be credited to the Water Fund and that no disbursements shall be made therefrom except on order of the City Council.
- 11) The ordinance provides for the payment of a bond fee and for turnoff on request from the consumer.
- 12) The ordinance reserves the right of the City to turn off water to make repairs or extensions to City property.
- 13) The ordinance reserves the right of the City to regulate the use of water for sprinkling and irrigation purposes.
- 14) The ordinance provides that any person who interferes, molests, injures, bypasses, or destroys any hydrant, pipe, main, meter, service box, or other appurtenance of the water system shall be guilty of a misdemeanor and subject to general misdemeanor penalties as prescribed in Idaho State law.

- 15) The ordinance provides for the proper disposal of sewage into the City sewer system.
  - 16) The ordinance provides that it shall be unlawful for any person to discharge stormwater or unpolluted water into the City sanitary sewer system.
  - 17) The ordinance provides for the types of sewer piping that may be used.
  - 18) The ordinance provides for billing on quarterly estimates and procedures.
  - 19) The ordinance provides for annexation as a condition of water and/or sewer service.
  - 20) The ordinance provides for the adoption of a cross connection control policy by resolution.
- e) The text of the ordinance and the specific content is available at City Hall for review and shall be promptly provided by the City Clerk to any citizen upon personal request.
