BURN PERMITS REQUIRED
May 10 - November 10

BURNING IN THE GRANGEVILLE CITY LIMITS

Burn Requirements:

Burning in the City of Grangeville is prohibited between May 10th and November 10th unless a permit is issued by the Fire Chief or his assistants. In unusually dry years, these dates are subject to change. To receive the most up to date information, please contact City Hall.

During open burning (November 11th through May 9th) a permit is not required; however adherence to the Burn Day Checklist is still required in order to ensure the safety of the burn.

Violation and Penalty:

The City of Grangeville passed Ordinance No. 839 to address burns in the City Limits. Any violation of this ordinance shall be a misdemeanor and shall be punished in accordance with the existing provisions of Idaho State law concerning punishment of misdemeanors occurring at the time of the violation.

Items Prohibited From Burning:

1. Burning barrels are prohibited at all times.
2. Municipal solid waste
3. Dead animals, animal parts, or animal waste of any kind
4. Motor vehicles, parts or materials
5. Tires or other rubber materials or products
6. Plastics
7. Asphalt or composition roofing or any other asphaltic material
8. Tar, tar paper, waste or heavy petroleum products or paints
9. Lumber or timbers treated with preservatives
10. Insulated wires
11. Pathogenic wastes
12. Hazardous wastes

Unrestricted Forms of Burning:

1. Barbecues
2. Ceremonial Fires
3. Camp Fires
4. Fire Places

Burn Day Checklist:

- ✓ Have a signed and approved permit at the burn location. (May 10th - November 10th only)
- ✓ Notify Dispatch, 983-1100, prior to lighting the approved burn.
- ✓ Have fire suppression equipment available (i.e. shovels, hoses, fire extinguishers, heavy equipment).
- ✓ Properly attend the burn until completely extinguished.
- ✓ Notify Dispatch, 983-1100, when the burn is completed.
- ✓ If the burn becomes too large or dangerous to contain, call 911 to have the fire department respond.
