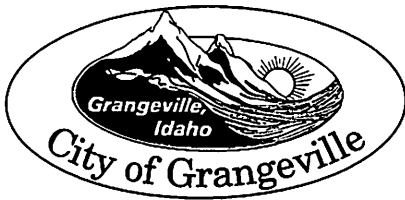

## Fact Sheet: Parking, Storage and Occupancy of Recreational Vehicles, Trailers and Motor Homes

The council recently adopted an ordinance prohibiting the storage of trailers, boats and motor homes on city streets. In order to highlight the changes, we've created this fact sheet listing many of the important changes. ***Please note: Any trailer, boat or motor home stored on a city street must be moved to private property.***

- A nonmotorized towed trailer, recreational vehicle, boat, storage container or motor home can't be:
  - Stored on any city street/alley; or
  - Parked or left unattended in a condition that is inoperable and unable to be moved; or
  - Parked within forty feet (40') of an intersection; or
  - Parked or left unattended in a manner that impedes or renders dangerous the movement of vehicular or pedestrian traffic.
- "Store" or "Stored" shall mean parking or placement of a nonmotorized towed trailer, recreational vehicle, boat, or motor home between the hours of 2:00 AM through 4:00 AM for three (3) consecutive days on any City street, alley, roadway, or right-of-way.
- Permits to store a trailer on a city street can be issued at City Hall for two reasons:
  - A 21-day permit for a utility trailer or storage container for construction services at a job in the city. Permit may be renewed.
  - A permit to allow a recreational vehicle or motor home to be parked on the street for temporary housing of non-residents visiting Grangeville for up to 14 days twice a calendar year.
- No person can live in a recreational vehicle, automobile or boat in the city except in an established recreational vehicle park. The temporary short-term occupancy of a recreational vehicle on private property up to 14 continuous days for a maximum of 28 days per calendar year does not violate this section.
- Violation of this ordinance is an infraction.
- Failure to comply may cause the trailer, boat or motor home to be removed and stored in a public or private storage lot, at the owner's expense.
